To safeguard the Integrity of the Police and Crime Commissioner for Wiltshire and Swindon, declarations of interest are publicly made. This ensures openness and transparency.

All declarations should be made following election to the post and reviewed annually as a matter of course. The Commissioner can update the declarations at any time should his or her circumstances change.

The declarations will be held on a register in the Office of the Police and Crime Commissioner and will be made available the OPCC website.



'relevant person' means the person(s) who is/are elected/appointed Police and Crime Commissioner and Deputy Police and Crime Commissioner.

'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000(b) and other securities of any description, other than money deposited with a building society.
