

- 'body in which the relevant person has a beneficial interest' means a firm in which the relevant person is partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;
- 'relevant person' means the person(s) who is appointed as a member of the Joint Independent Audit Committee;
- 'securities ' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
