- 'relevant person' means the person(s) who is appointed as a member of the Joint Independent Audit Committee;
- 'securities ' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
